

CALL FOR ABSTRACTS AND PRESENTATIONS



The Campus Program provides training and technical assistance to institutions of higher education that are the recipients of the “Grants to Reduce Domestic Violence, Dating Violence, Sexual Assault and Stalking on Campus Program” through the Office on Violence Against Women (OVW) at the U.S. Department of Justice (DOJ).

The CALCASA Campus Program holds two-day Training and Technical Assistance (T&TA) Institute for grantee recipients and is currently soliciting proposals on violence against women as it relates to the college and university community.

We are seeking presenters that can provide workshops focusing on sexual assault, stalking/ cyber stalking, and domestic/dating violence. Workshops must be applicable to attending grantee demographics (such as urban, rural). The purpose is to provide information that is applicable to all participating grantees. Workshops in monolingual Spanish are encouraged.

All workshops must address how the topic impacts campus work with underserved communities such as people of color, tribal/indigenous, lesbian/gay/bisexual/transgender/intersex/queer (LGBTIQ), people with disabilities, Deaf students, and immigrants with an emphasis on the following:

Title of your presentation.

Abstract

Limit your abstract to 350 words or less.

Contact Information

Include name, title, telephone number, fax number, web address, email address and mailing address for each person who will be presenting.

Biography

For each person who will be presenting, please limit your biography to 250 words or less. Biographies may be edited due to space limitation.

Curriculum Vitae (CV)

For each person who will be presenting.

Technological Alternatives

For each person who will be presenting, submit any video/audio presentation (i.e. youtube, podcasts, etc.) if applicable.

Previous CALCASA Campus TTI Speaker Participation

For each person who will be presenting, please indicate the TTI (location and year) attended and title of presentation.

Note: Laptops will NOT be provided.

Each workshop is 90 minutes in length.

There are approximately 75 participants in each workshop. If you will have handouts, please bring enough copies for each workshop (approximately 150 copies total).

Presenters are expected to present their workshop twice.
