
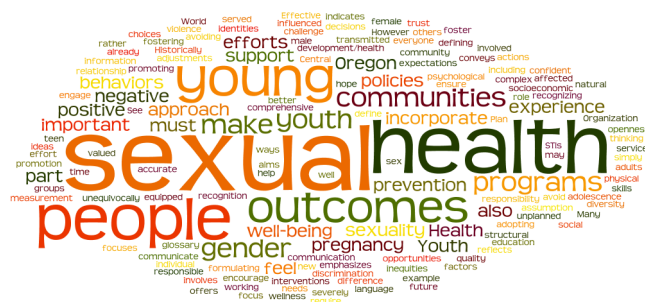

Expanding Our Approach

From Teen Pregnancy
Prevention to Sexual Health,
Safety and Well-being

The plan includes five overarching goals:

- Youth use accurate information and well-developed skills to make thoughtful choices about relationships and sexual health.
- Sexual health inequities are eliminated.
- Rates of unintended teen pregnancy are reduced.
- Rates of sexually transmitted infection are reduced.
- Non-consensual sexual behaviors are reduced.



Objectives

- > Build state and community infrastructure.
- > Develop supporting policies.
- > Address health inequities.
- > Promote youth development and opportunities.
- > Provide education and skill building for youth and families.
- > Provide services for youth and families.
- > Collect and monitor data.
- > Measure effectiveness.



HB 2509

- (i) Teach students that no form of sexual expression is acceptable when the expression physically or emotionally harms oneself or others and teach students not to make unwanted physical and verbal sexual advances, how to decline unwanted sexual advances or accept the refusal or unwanted sexual advances.

HB 2509

- (i) continued...

Students shall be taught that it is wrong to take advantage of or to exploit another person. Materials and information shall be presented in a manner sensitive to the fact that there are students who have experienced sexual abuse.

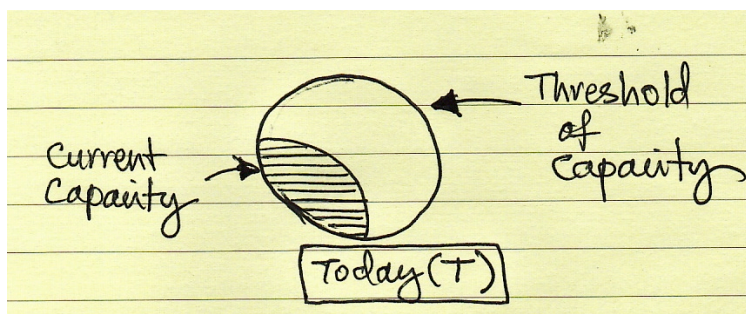

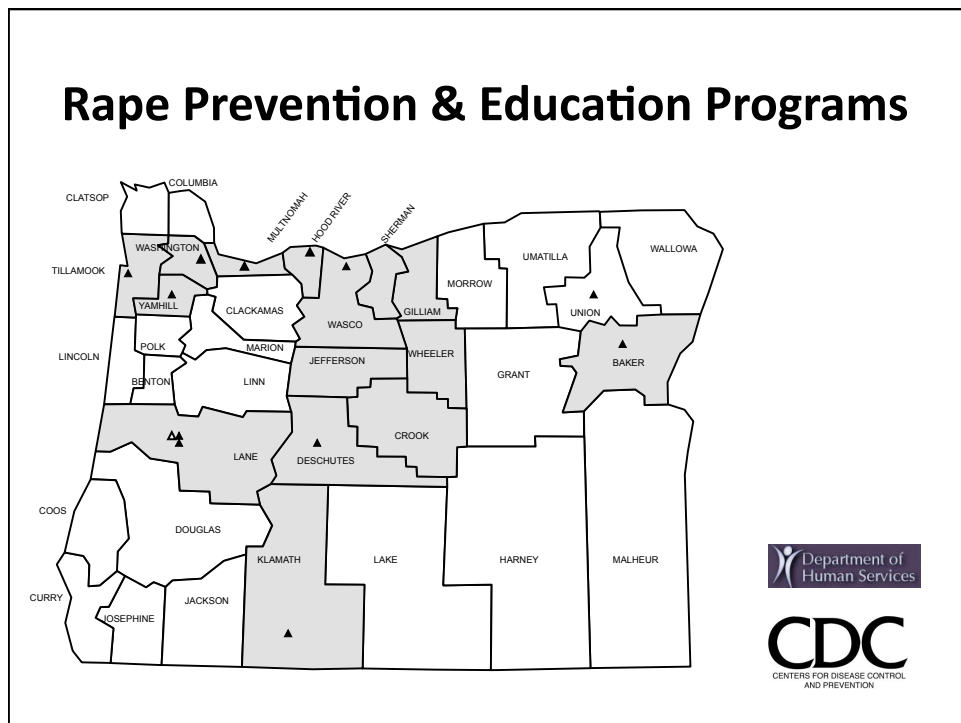
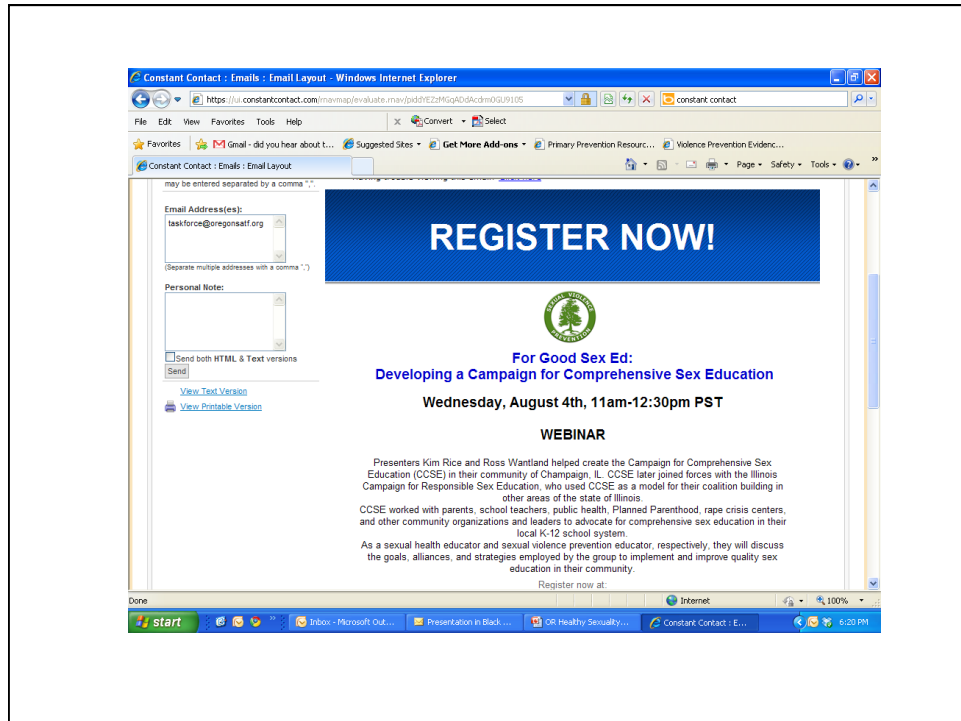
